McConduck (2004) asserts that science fiction writers have used the intelligent machines to advance the fantasy of intelligent non-humans, as it relates to human characteristics. # **Application of Expert System in library Cataloguing**

Cataloguing is a technical process, that is rule based (AACR) designed by librarians for all print and non-print resources in all library or information center in order to provide information access to library patrons. It is referred to as an interpreter or index to library collections. Recent attempts to automate cataloguing through expert systems have focused on descriptive cataloguing because it is considered rule-based (AACR2). Mogali (2015) highlighted two approaches for applying artificial intelligence techniques to cataloguing which are:

- Human-machine interface, where the intellect effort is divided between the intermediary and the support system; and
- An expert system with full cataloguing capability linked to electronic publishing system, so that as a text is been generated on-line, it passes through knowledge base systems and cataloguing process is done without any intellectual input from an intermediary. Thus, this system would provide a means for retention of complex knowledge and scarce expertise.

#### **Application of Expert System in library classification**

Classification is the fundamental activity in the organization of knowledge. It is the grouping of knowledge into usable terms. It is one prominent task in all systems for organizing knowledge in libraries and information centers. Application of Expert system in the area of classification in libraries includes the following:

- Coal Sort: it is a conceptual browse, designed to serve either as a search or an indexing
  tool. Coal Sort consists primarily of frame-based semantic network and the software
  needed to allow users to display portions of it and to move around in the conceptual
  structure. The expert knowledge in the system is embodied almost entirely in the
  semantic network.
- EP-X: the environmental pollution Expert (EP-X) has certain things in common with coal SORT because both enhances interface using a knowledge based approach. The knowledge base of EP-X consists of hierarchical frame-based semantic networks of concepts and a set of template that express the patterns called the pragmatic relationships among concepts.
- BIOSIS: Biosis also an expert system that uses knowledgebase, combine within significant amount of procedural knowledge, to assign documents to categories automatically. It is designed as an indexer aid. BIOSIS uses the information in the titles of documents to assign as many categories as possible of those that would be assigned by human indexers. The indexing languages are structural and practical representation of information that can be used to a very good advantage of AI application.

## **Application of Expert Systems in Reference Service**

Reference service is a prime and sensitive activity of any library and the expert system will work as a substitute for a reference librarian. The following are some of the examples of Expert systems used for reference services:

- Research: It is a system that supplies patrons, the recommended sources to lookup for certain questions. The system can be used to teach students reference skills or as a computerized and for practicing reference librarians and information specialists.
- Pointer: This is one of the earliest applications of computer system in the area of reference service called computer assisted reference program, it directs the users to the reference sources.
- Online Reference assistance (ORA): This system intended to stimulate the services of an academic reference librarian for questions of low and medium level by using several technologies, a videotext like database, computer assisted instruction modules and knowledge based system. It is a 24/7 response services currently utilized by big companies.
- Answer man: This is also knowledge based system to help users for reference questions
  on topics. It uses series of menus to narrow down the subject of the questions and the
  type of tool needed. It can function as either a consultation system or as front end to
  external databases and CD-ROM reference tools.

• Plexus: This is a referral tool used mostly in public libraries. It provides knowledge about the reference process, information retrieval about all subject areas, reference sources and library users.

### **Benefits of Artificial Intelligence to Library Service Delivery**

Libraries in the western world have long benefitted from AI "Robotics". These new technologies have the capacity to imitate human intelligence by performing various tasks that require thinking and learning, solving problems and making various decisions without human interference. Moreover, due to the lack of ability of human beings to learn and understand how these tools work they have little or no control over the system which is further complicated as automated systems become more prevalent and complex.
