This is due to the fact that many nations do not have the resources necessary to measure the literacy rates in their own nations.

Literacy, which is defined as the state of being literate, is appended as a phrase following various nouns and is used differently from the concept of functional literacy. The phrase "literacy" refers to the state of being literate. Information literacy began as a users' education program or bibliographic teaching that emphasized the utilization of library tools; however, Ojedokun and Lumande (2005) stated that the scope of information literacy has significantly broadened since its antecedents. These antecedents include bibliographic instruction or users' education programs. However, it is important to keep in mind that information literacy is the cornerstone of continuous education throughout one's life. According to Majetic and Pellegrino (2018), information literacy comprises the capacity to locate information, comprehend how it is generated, appraised, and used in the process of developing new knowledge, and act ethically in the educational setting. According to Banik and Kumar (2019), if undergraduate students had appropriate information literacy abilities, their academic performance would greatly increase, and this improvement might contribute to the overall growth of the country.

Learners may expand their investigations, become more self-directed, and take more responsibility over their own learning when they have information literacy as a tool at their disposal, which helps them to understand the topic at hand and further their research. Tharanganie et al. (2011) asserted that a student is considered "computer literate" if he/ she possess all the following six skills:

- Skills in basic hardware and basic operating system functions-identifying computer parts, powering up and shutting down the computer, opening/saving files, and recognizing different file types.
- Skills in word processing-Create, save, print document, insert tables/ charts/labels/symbols, format page layout (margins, page number, and page borders).
- Spreadsheet skills- create/save/print spreadsheets, insert tables/ charts, insert function and formula.

- Skills in presentation graphic create/save/print slide shows, insert new slide/layout/tables/charts and create animations.
- Skills in databases-Design basic databases with queries and reports/forms.
- Skills in internet and e-mail-surfing the Internet and sending email messages.

The phrase "computer literacy" has evolved into what is now more widely known as "information literacy" as a result of advances in technology. Information literacy is defined by Devi et al. (2018) as the capacity to determine when information is required in addition to having the skills necessary to successfully access, evaluate, and apply the information that is required. This involves having a strong command of a variety of information and communications technologies (ICTs) as well as online information retrieval tools. According to Devi et al. (2018), obtaining success in today's commercial climate and academic setting, in which knowledge has become one of the most important intangible assets, requires these qualities as a prerequisite. Understanding how to make effective use of computers to manage the education process has emerged as a basic skill for those working in higher institutions in light of the growing prevalence of computer use. According to Ololube (2015), the acquisition of computer literacy abilities should start within the foundational or preliminary phases of the beginning stages of the undergraduate educational modules. A research conducted in the Kingdom of Bahrain by Al-Ammary (2012) confirmed that the use of educational technology might serve as a factor that encourages students to continue their education and students' success is mostly determined by their knowledge of and ability to utilize information and communications technology (ICT), particularly software.

#### **Digital Literacy**

The technical ability to operate digital devices correctly is only one aspect of what is referred to as digital literacy. Digital literacy also includes a variety of cognitive skills that are utilized in the process of carrying out tasks in digital environments, such as navigating the Internet, understanding user interfaces, working with databases, and participating in online chat rooms. (2012) thought of digital skills not only as the capabilities of operating computers and network connections, but also as the capabilities of searching for, selecting, processing, and applying information from a variety of various sources. We get into skills that can be learned with a low level of digital literacy because they are based on variables such as computer anxiety, poor self-efficacy, computer training, age, or gender, as Bunz et al.
