It posits that one-shot workshops are insufficient and that sustained, context-specific training is essential.

Fullan and Hargreaves (2016) echoed this sentiment, emphasizing the need for embedded professional development within the daily routines of teaching. Furthermore, Little (2008) suggests that effective teacher training should encompass a blend of collaborative learning experiences, reflective practices, and mentorship programs. On the use of technology in teacher training, Guskey and Yoon (2009) argued that incorporating digital tools can enhance the depth and reach of professional development, making it more accessible and adaptable. Capacity building involves continuous training and development for teachers, enhancing their skills and knowledge to deliver quality education. Invest in the training and professional development of

teachers to ensure they have the necessary skills and knowledge to provide quality education. Continuous training can help teachers stay updated with best practices in education.
