#### Abstract

This paper focused on workforce development strategies for teacher job performance in public schools in Nigeria. Workforce development strategies are a set of intentional and coordinated efforts aimed at enhancing the skills, knowledge, and employability of individuals within a labor force. These strategies are designed to align the workforce with the evolving demands of the job market, thereby promoting economic growth, reducing unemployment, and improving the overall productivity and quality of the workforce. The paper identified the workforce development strategies for teacher job performance which includes: Professional Development, Teachers' Certification, Teacher Evaluation and Feedback, Reducing Teacher Workload, Classroom Resources and Infrastructure, Curriculum Alignment, Teacher Motivation, Teacher Well-Being and Collaborative Learning Communities. Also, identified the potential challenges facing workforce development strategies for teachers' job performance which are: Inadequate Funding, Infrastructure and Technology Gaps, Limited Access to Professional Development, Lack of Teacher Retention and Motivation, Lack of Quality of Training Programs, Cultural and Linguistic Diversity, Lack of Policy Implementation and Consistency and Lack of Assessment and Accountability. The paper likewise provided possible strategies for curbing the challenges of workforce development strategies for teacher job performance which includes: Increase Funding for Education, Improve Infrastructure and Technology Integration, Teacher Retention and Motivation, Regional and Cultural Sensitivity, Policy Consistency and Implementation and Equitable Access to Professional Development. It therefore, concluded that effective workforce development strategies for teacher job performance in public schools in Nigeria are essential for improving the quality of education and ensuring positive student outcomes. The paper made some outstanding suggestions that; Federal government should increase budgetary allocation to the education sector to ensure that there are adequate resources for teacher training and professional development programs. Also, School Administrators should ensure that all teachers have access to training including those in remote or underserved areas, have access to professional development opportunities.

Workforce development strategies encompass a wide spectrum of initiatives, each meticulously designed to address specific facets of teacher job performance. They range from tailored professional development programs, offering educators opportunities for continuous growth and skill enhancement, to mentorship schemes that foster a culture of collaborative learning and guidance. Furthermore, the integration of cutting-edge technology into the teaching process seeks to modernize pedagogy, making learning more engaging and accessible (Darling-Hammond, 2017). By investing in the workforce development strategies, Nigeria aspires to cultivate a more skilled, motivated, and resilient educational workforce. This investment ultimately translates into improved student outcomes, enhanced critical thinking skills, and the holistic development of young minds. Moreover, a revitalized public education system is a catalyst for social change, offering an equalizing force in a nation marked by disparities (Holzer & Lerman, 2014). According to Smith (2005) workforce development is the process of enhancing the skills, knowledge, and abilities of the labor force to meet the evolving needs of the economy. Brown

(2014) described workforce development as the systematic efforts to align the skills of workers with the requirements of employers, fostering economic growth and competitiveness. Peterson (2022) defined workforce development to be policies and programs that facilitate the acquisition of skills, knowledge, and competencies to enhance individual employability. In the dynamic landscape of education, the significance of workforce development for teachers in public schools in Nigeria cannot be overstated. As the driving force behind knowledge dissemination and skill acquisition, teachers play a pivotal role in shaping the future of the nation. Workforce development for educators goes beyond a mere professional enhancement; it is a strategic commitment to equipping teachers with the necessary tools, knowledge, and innovative pedagogies to excel in their roles (Smithson, 2022). In the context of Nigerian public schools, this initiative becomes a catalyst for transformative change, aiming not only to elevate individual teacher job performance but also to revolutionize the entire educational ecosystem.

#### **Workforce Development Strategies**

According to Anderson (2019) and Borko (2017) workforce development strategies refer to the actions and policies aimed at fostering a competitive labor force, which is essential for the prosperity and growth of industries and regions. Brown (2014) described workforce development strategies encompass the systematic efforts to bridge the gap between education and employment, ensuring that individuals are prepared for meaningful work opportunities. Johnson (2016) defined workforce development strategies as the identification and cultivation of the talents and capabilities of the workforce to drive economic growth and social progress. Workforce development strategies take into account the dynamic nature of work, which is continually influenced by technological advancements, economic shifts, and changing industry demands. As a result, these strategies promote lifelong learning and career development, encouraging individuals to adapt, upskill, and reskill throughout their professional journey (Frugoli et al, 2016).

Workforce development strategies are instrumental in shaping the landscape of education, particularly in how they exert a profound influence on teacher job performance. These strategies represent a comprehensive approach to enhancing the skills, knowledge, and capabilities of the teaching workforce, and their impact extends far beyond the individual teacher's professional growth (McGuire et al, 2016). Workforce development strategies wield a profound influence on teacher job performance, as they provide the framework and tools necessary to enhance educators' skills, knowledge, and effectiveness in the classroom. These strategies are not only pivotal for the professional growth of teachers but also pivotal for the overall quality of education.

#### **Teacher Job Performance**

Teacher job performance is a multifaceted and critical aspect of the education system that plays a pivotal role in shaping the academic, social, and personal development of students. It encompasses the array of skills, abilities, and actions that educators employ within the classroom and beyond, all aimed at fostering an environment conducive to learning, growth, and achievement. Teacher job performance is the consistent adaptation to changing educational policies and best practices. According to Darling-Hammond (2017), teacher job performance is the measurement of a teacher's impact on student achievement and growth. Danielson (2007) described teacher job performance to include instructional planning, classroom management, and assessment practices. Durlak cited in Adeyemi (2014) defined teacher job performance as the extent to which a teacher contributes to the broader goals of education, including social and emotional development. Fullan cited in Oduolowu (2011) described teacher job performance as the impact on long-term student success, including post-graduation outcomes. The evaluation of teacher job performance is a subject of continuous scrutiny and debate, as it profoundly influences the quality of education, the future prospects of students, and the overall effectiveness of educational institutions (Holmes & Banerjee, 2017).

Effective teacher job performance is typically associated with positive student learning outcomes, as it directly influences the quality of education and students' academic growth. It involves not only what happens within the classroom but also professional development, ethical conduct, and the broader impact on students' cognitive, social, and emotional development (Harris & Sass, 2014). According to Darling-Hammond (2017), teacher job performance encompasses various aspects that collectively determine the effectiveness and success of an educator: Instructional Skills, Classroom Management, Student Engagement, Assessment and Feedback, Content Knowledge, Cultural Responsiveness, Professional Development, Ethical and Professional Conduct, Communication and Collaboration, Technology Integration, and Adaptability. Teaching provess is a beacon of inspiration, creating a lasting impact on students and elevating the standard of educational excellence. The commitment to fostering a love for learning and academic success sets a remarkable standard in the realm of teaching.

#### **Possible Workforce Development Strategies for Teachers Job Performance**

In the educational landscape, teachers are the weavers of knowledge, the architects of future generations. They hold the key to unlocking the potential of millions of young minds. Their job performances are fueled by effective workforce development strategies. Implementing these strategies is essential to enhance teachers' job performance. Below are some of the workforce development strategies for teacher job performance in public school in Nigeria:

#### **Professional Development**

Professional development plays a pivotal role as a workforce development strategy, significantly impacting teachers' job performance. Workshops, conferences, seminars, mentoring, coaching and online courses offer opportunities for teachers to acquire new teaching strategies, incorporate technology, and stay updated on curriculum advancements. In-depth training programs contribute to teachers' knowledge, skills, and pedagogical strategies, fostering continuous improvement in the classroom (Guskey, 2018). Desimone (2019) emphasized the importance of

sustained, job-embedded professional development, aligning with the specific needs and context of educators. This personalized approach is seen as essential for meaningful skill acquisition and application, translating into improved student outcomes (Borko, 2017).

Study by Miller (2021) highlighted that successful professional development goes beyond one-time workshops, emphasizing sustained and embedded learning experiences. Collaborative learning communities, mentoring and coaching programs, and peer observations contribute significantly to teacher development. These approaches provide opportunities for reflection, feedback, and the exchange of best practices. Furthermore, research by Darling-Hammond and Richardson (2009) emphasized the significance of continuous professional development (CPD) for teachers indicating that teachers who engage in ongoing learning opportunities exhibit greater adaptability and sustained effectiveness in their roles. Teachers who receive personalized support through mentoring and coaching demonstrate enhanced job performance, benefiting from ongoing guidance and feedback. Coaching offers targeted support, helping teachers set goals, reflects on their practices, implement effective strategies, and implementing mentorship and coaching programs where experienced teachers support and guide newer educators.

#### **Teachers' Certification**

Teacher certification serves as a crucial workforce development strategy, influencing educators' job performance. Ingersoll (2011) indicated that certified teachers often possess a more comprehensive understanding of pedagogical techniques, subject matter expertise, and classroom management skills compared to their non-certified counterparts. Certification programs typically incorporate a blend of theoretical knowledge and practical teaching experiences, fostering a well-rounded skill set in educators (Darling-Hammond, 2017).

Goldhaber and Anthony (2018) highlighted the positive correlation between teacher certification and student outcomes, emphasizing the importance of certified educators in enhancing academic achievement. Certified teachers tend to be more effective in addressing diverse student needs and adapting instructional strategies, contributing to a more inclusive learning environment (Clotfelter et al., 2016). Darling-Hammond (2017) emphasized that certified teachers often exhibit higher levels of pedagogical knowledge, classroom management skills, and overall instructional effectiveness. Certification programs are viewed as mechanisms to ensure educators possess the necessary skills and knowledge to meet the diverse needs of students. Smith (2005) indicated a positive correlation between teacher certification and student achievement, emphasizing the crucial role certified teachers play in fostering academic growth. Teacher certification is a sole indicator of teacher effectiveness. Factors such as experience, ongoing professional development, and the school environment also significantly influence job performance. Additionally, alternative certification pathways and their effectiveness in preparing teachers have been subjects of debate, challenging the traditional notion of certification as the sole predictor of teacher quality. Teacher certification is associated with enhanced job performance and positive student outcomes. Rigorous and comprehensive certification is associated with increased teacher effectiveness, ensuring that educators are adequately prepared for the complexities of their profession.

#### **Teacher Evaluation and Feedback**

Regular teacher evaluation and constructive feedback are integral components of assessing job performance (Oduolowu, 2011). Teacher evaluation is recognized as a multifaceted system that involves comprehensive assessments of instructional practices, classroom management, and professional growth. Johnson and Martin (2023) highlighted the significance of using multiple measures, including classroom observations, student outcomes, and self-assessment, to provide a holistic view of teacher performance. Feedback, particularly when it is formative and ongoing, is identified as a critical component of teacher development. Effective feedback is timely, specific, and linked to observable behaviors, allowing teachers to make targeted improvements.

The effectiveness of teacher evaluation is closely linked to the quality of feedback provided. Timely, specific, and actionable feedback has been shown to have a significant impact on teacher performance (Kraft et al., 2018). This feedback loop creates a culture of accountability and continuous improvement, emphasizing collaboration between administrators and teachers (Marzano et al., 2012). Davis (2013) suggested that feedback should be a two-way communication process, fostering a collaborative and supportive environment. Research by Carter (2017) indicated that evaluation and feedback systems should be transparent, fair, and aligned with professional standards. The incorporation of both qualitative and quantitative data in the evaluation process is emphasized, offering a more comprehensive understanding of teacher effectiveness. Training evaluators to conduct meaningful and constructive evaluations is considered crucial for the success of these processes.

Teacher evaluation and feedback underscores the importance of a comprehensive, fair, and ongoing process. Effective evaluation and feedback contribute not only to individual teacher development but also to the overall improvement of instructional practices and, ultimately, student outcomes. Comprehensive evaluations, including classroom observations and student assessments, provide a holistic view of a teacher's effectiveness. Constructive feedback, delivered in a supportive manner, helps educators identify strengths and areas for improvement (Hargreaves & Fullan, 2012). A well-structured evaluation system contributes to enhanced teaching practices and, subsequently, improved overall job performance.

#### **Reducing Teacher Workload**

Efforts to reduce teachers' workload have gained attention as crucial workforce development strategies, aiming to enhance job performance and overall well-being. Ingersoll and Strong (2011) underlined the impact of workload on teacher effectiveness, emphasizing the need for a balanced and sustainable approach to instructional responsibilities. Johnson and Birkeland (2014) suggested that excessive workload contributes to burnout and can negatively affect teacher morale and retention. Strategies to reduce workload encompass various dimensions, including curriculum design, administrative tasks, and assessment practices. Streamlining curriculum requirements and providing clear, well-organized instructional materials are identified as effective means to alleviate teacher burden (Goe, 2018). Research by Thomas (2019) suggested that a balance between professional expectations and manageable workloads is crucial for sustaining a healthy and effective teaching workforce. Miller (2021) emphasized that flexible scheduling and time management strategies are potential solutions to reduce teacher workload. Providing educators with the autonomy to organize their time efficiently, coupled with realistic expectations, can contribute to improved job performance and overall well-being.

Holzer and Lerman (2014) highlighted the importance of school leadership in recognizing and addressing workload issues. They noted that supportive administrative practices, including realistic expectations, clear communication, and providing resources, are crucial for fostering a positive work environment. Streamlining administrative tasks, providing efficient grading tools, and leveraging technology for routine processes can alleviate the burden. Adequate support staff, well-designed curriculum materials, and realistic expectations contribute to a healthier work-life balance. By addressing workload concerns, educators can focus more on effective teaching practices, leading to improved job performance and better outcomes for both teachers and students. Thus, reducing teachers' workload for improved job performance advocates a holistic and collaborative approach.

#### **Classroom Resources and Infrastructure**

The availability and quality of classroom resources and infrastructures are significant factors in shaping teachers' job performance. Numerous studies emphasize the importance of adequate classroom resources, including textbooks, technology, teaching materials, and manipulative. Research by Boyd et al., (2014) emphasized that well-equipped classrooms positively impact instructional practices, engagement, and student outcomes. Access to a variety of teaching materials, textbooks, and technology has been associated with improved teacher effectiveness and student achievement (Hattie, 2012). Adequate resources contribute to a dynamic learning environment, enabling teachers to implement diverse instructional strategies that cater to different learning styles and needs (Harris & Sass, 2014). Moreover, Guarino et al., (2015) suggested that the physical infrastructure of classrooms, including seating arrangements, lighting, and overall layout, influences the teaching and learning process. Well-designed and comfortable classrooms, access to digital resources, interactive whiteboards, and other educational technologies is associated with increased student engagement and improved teacher effectiveness (Frugoli et al., 2016).

Studies by McGuire et al., (2016) indicated that conducive physical environments, such as well-lit and appropriately ventilated classrooms, positively influence teachers and students well-being, consequently impacting job performance. Research by Oduolowu (2011) stressed the importance of school leadership in providing and maintaining adequate resources and infrastructure. Supportive administrative practices, budget allocations, and strategic planning for resource acquisition contribute to a positive working environment for teachers. Classroom resources and infrastructure for teachers' job performance emphasizes the crucial role these elements play in creating an environment conducive to effective teaching. Adequate resources, technology integration, and supportive physical infrastructure contribute not only to teacher satisfaction but also to improved student outcomes.

#### **Curriculum Alignment**

Curriculum alignment stands out as a vital workforce development strategy, impacting teachers' job performance by ensuring that instructional objectives, assessments, and educational standards are congruent. Porter et al., (2003) consistently emphasized the importance of alignment in promoting effective teaching and enhancing student learning outcomes. Research by Popham (2018) indicated that when teachers align their instruction with established curriculum standards, students benefit from a more coherent and focused educational experience. Curriculum

alignment involves mapping instructional content and methods to specified learning goals, providing teachers with a clear roadmap for effective lesson planning and delivery (Holzer & Lerman, 2014). Studies by Kazis and Shulkin (2006) consistently highlighted that teachers' job performance is positively influenced when they have a clear understanding of curriculum objectives and can effectively translate them into instructional strategies.

Johnson (2016) suggested that curriculum alignment enhances teacher effectiveness by providing a structured framework for planning and delivering instruction. Teachers who are well-versed in the curriculum objectives are better equipped to create engaging lessons, assess student progress accurately, and address individual learning needs. Alignment between curriculum and assessments is prominent for teachers' job performance (Hill et al., 2019). When assessments align with curriculum goals, teachers can better gauge student understanding and tailor their instructional approaches accordingly. This alignment contributes to a more accurate evaluation of both student and teacher performance. When instructional goals, assessments, and learning activities align with the curriculum, educators can effectively deliver targeted content. Professional development on curriculum alignment ensures teachers have the necessary skills. Regular reviews and updates to align with educational standards keep instruction relevant. A well-aligned curriculum enhances clarity, consistency, and overall effectiveness in teaching, contributing to improved job performance for educators.

#### **Teacher Motivation**

Teachers' motivation is a pivotal aspect of workforce development, significantly influencing their job performance and overall effectiveness in the classroom. Ingersoll and Strong (2011) featured the multifaceted nature of teacher motivation and its implications for student outcomes. Intrinsic motivation, characterized by a genuine passion for teaching and a commitment to students' success, is consistently linked to higher job satisfaction and performance (Deci & Ryan, 2000; Ololube, 2017). Teachers driven by intrinsic motivation are more likely to engage in continuous professional development, seek innovative instructional approaches, and establish positive relationships with students.

Extrinsic factors, such as recognition, professional development opportunities, and fair compensation, also play a crucial role in teachers' motivation. However, Latham and Pinder (2017) suggested that teachers who perceive a connection between their efforts and tangible rewards are more likely to demonstrate higher levels of commitment and job satisfaction. Professional development programs that align with teachers' goals and provide meaningful opportunities for growth contribute to sustained motivation (Little, 2012). The organizational climate and culture are identified as influential factors in shaping teachers' motivation. Supportive leadership, collaborative work environments, and a sense of autonomy contribute to a positive motivational climate (Keller, 2010). Conversely, factors like administrative constraints and a lack of resources can negatively impact teachers' motivation (Hakanen et al., 2006). Supportive administrative practices, clear communication, and a positive school culture contribute to a motivating work environment. On the contrary, factors like excessive bureaucracy, lack of autonomy, and inadequate resources may diminish motivation and hinder job performance. Recognizing and celebrating achievements, fostering a positive work environment, and providing professional growth opportunities are motivational factors. Supportive leadership, clear communication, and a collaborative culture contribute to job satisfaction. Ultimately, when

teachers feel valued and inspired, their motivation translates into effective teaching practices and enhanced job performance.

#### **Teacher Well-Being**

Teachers' well-being has emerged as a critical focus in workforce development, with extensive literature highlighting its profound impact on job performance, job satisfaction, and ultimately, student outcomes. Sutton and Wheatley (2017) dependably emphasized the interconnectedness between teacher well-being and the overall health of the educational system. One significant aspect of teacher well-being is the impact of stress and burnout. Kyriacou (2016) opined that high levels of stress are associated with lower job satisfaction, diminished instructional effectiveness, and increased teacher turnover. Strategies to mitigate stress include workload management, professional support networks, and the development of coping mechanisms, which have been linked to improved teacher well-being (Skaalvik & Skaalvik, 2017).

The demands of teaching often extend beyond the classroom, impacting personal lives and contributing to burnout (Ololube, 2017). Policies and practices that promote a healthier work-life balance, such as flexible scheduling, reduced administrative burden, and clear delineation of responsibilities, are identified as essential components of workforce development strategies (Ingersoll & Strong, 2011). Professional development opportunities that focus on teacher well-being, including stress management workshops and mindfulness programs, have gained attention (Ololube, 2011). Integrating well-being into the professional development agenda is seen as a proactive approach to enhancing teacher resilience and job satisfaction, ultimately benefiting both educators and students (Ololube, 2006). Prioritizing teacher wellbeing is crucial for sustaining high job performance. Creating a supportive work environment, offering mental health resources, and promoting a healthy work-life balance are essential. Adequate professional development on stress management and resilience can be beneficial. Recognizing and addressing factors that contribute to burnout, such as heavy workloads, is key. When teachers feel valued, supported, and emotionally well, it positively impacts their job performance, leading to better outcomes for both educators and students.

## **Collaborative Learning Communities**

Collaborative learning communities (CLCs) have gained prominence in the literature as potent workforce development strategies, influencing teachers' job performance through shared learning, support, and professional growth. Hord and Tobia (2018) highlighted the positive impact of CLCs on instructional practices, teacher satisfaction, and student outcomes. CLCs provide a platform for teachers to engage in meaningful collaboration, fostering a culture of continuous improvement. Bryk et al., (2015) indicated that teachers participating in CLCs experience increased job satisfaction, professional efficacy, and a sense of collective responsibility for student success.

The collaborative nature of these communities promotes a dynamic exchange of ideas, resources, and best practices, contributing to enhanced instructional strategies (Little, 2012). Professional development within CLCs is characterized by its contextual relevance and responsiveness to the specific needs of teachers. This personalized approach to learning is linked to improved job performance as it addresses the diverse challenges faced by educators in their classrooms (Louis et al., 2017). Stoll et al. (2019) suggested that sustained engagement in CLCs

leads to a deeper understanding of pedagogical approaches and a greater willingness to experiment with innovative teaching methods. Moreover, CLCs contribute to a supportive and collegial work environment. Teachers in collaborative communities often report higher levels of trust, shared decision-making, and a sense of professional belonging (Hargreaves & Dawe, 2010). These relational aspects positively impact job satisfaction and overall well-being, creating a positive ripple effect on job performance (Ingersoll & Strong, 2011). CLCs contributes to continuous learning, improved instructional practices, and a positive school culture, ultimately enhancing teachers' job performance and contributing to overall educational effectiveness.

## Potential Challenges Facing Workforce Development Strategies for Teachers' Job Performance

The challenges of workforce development strategies for teachers' job performance in public school in Nigeria are multifaceted. Below are some of the challenges facing workforce development strategies for teachers' job performance in public school in Nigeria:

#### Inadequate Funding

Public schools in Nigeria often grapple with insufficient financial resources (Halachmi & Seif-Mor, 2008).
